Hinrichs stated that she had received a Letter of Resignation for Greg Maddalone and that it was effective on 10/01/2017. Leif motioned to accept Maddalone's resignation. Nelson second. Roll call taken:

Treasure's Report enclosed. After review of her report it was asked if the Village is paying more for garbage than was collected and if Promenschenkel has had the opportunity to check if the garbage rate was correct and that the increase had been applied. She stated she had not. It was then asked if the water and sewer income has been separated as asked and it had not.

Williams motioned to approve a credit card for Police Chief with a \$500.00 limit. Newstrand second. Roll call taken:

Williams stated that Chief Craft asked that Officers Looney, Flynn and Woodley be allowed to attend training in Dixon on November 8, 2017. He stated the cost of the class is through the Northwest Criminal Justice Commission and there is no charge.

Williams stated that questions were brought up about a firearm that is no longer in the possession of the Village of Chadwick. Jensen stated that Craft had brought up questions about a firearm that a WWII widow had given to the Police Department. It was brought up that the gun had been to taken to Carroll County Sheriff's office for storage and at sometime Scott Marth had move the gun to the Chadwick Police Department and then given it to the Milledgeville Police Department. When Craft found out about it he contacted Milledgeville Chief and was told the gun has since been registered to the Milledgeville Police Department. Jensen stated that if Chief Marth had attempted to give it away, he had no right to do so. After discussion the Board directed Jensen and Craft to work together to put a letter together requesting the return of the gun in question. It could just be a misunderstanding between the two communities.

Morgan made a motion to purchase a file cabinet to store blue prints not to exceed spending \$350.00. Newstrand second. Roll call taken:

Morgan motioned to purchase PVC pipe to replace the clay tile on the east line from the railroad tracks to the lagoon not to exceed \$15,000.00. Newstrand second. Hinrichs asked about the connection into the manhole. Newstrand stated that due to the lack of water the electric bill has dropped. Nelson asked

if anyone has checked into how much was spent out of the Water and Sewer account so we know if the Village has the money to complete this project. Nelson stated she has not received a budget vs actual to know what is left in the budget. Morgan and Newstrand withdrew their motion. Morgan motioned to refer the purchase/repairs to Fink's fields to committee. Newstrand second. Roll call taken:

It was stated that Newstrand and Nelson had reviewed water bills and found a few issues that need to be addressed. The issues were written down and will be given to Promenschenkel for corrections. Leif then asked about notes that have been made that payments will be made and that no one single person can make those decisions. Nelson stated if the total bill is not paid it should be shut off per the Village Code Book. Bottom line is the Water and Sewer account is loosing money and the cycle needs to be stopped. Jensen stated that some of the language in the code book (paragraph E)needs to be looked at in regards to water bill disconnects. Jensen suggested that the people that have paid their principle be left on and the late fees be addressed next month once the Board had has a chance to review the letter the disconnect letter that was sent out.

Nelson made a motion to ratify payments to the landlord for the apartments on 5th street to refund charges and late fees excluding the \$25.00 late fee. Leif second. Roll call taken:
